Terms & Conditions of Sale and Entry

Outback Spiritual Festival ("Festival") is presented by Outback Spiritual Festival (ABN 582 793 025 36) ("Organiser").

The purchase of the entry ticket to the festival ("the Holder").

Tickets, stall or contributor fees which are sold, gifted or allocated by the festival are done so on the express condition that the holder is bound to the following terms and conditions of sale and entry, which form part of the contract between the festival and the holder. The Terms and Conditions of Sale and Entry apply to all visitors to the festival site.

General Refunds Policy

1. A change in personal circumstances (interest, medical, work or family related) of the holder does not entitle the return or exchange of the wristband.

2. Tickets and other expenses associated with the festival will not be refunded in whole or in part under any circumstances including, but not limited to, holders being asked or forced to leave, holders deciding not to attend any portion of the festival, the possible non-appearance of any particular person, expected by the holder, whether advertised or not.

3. Holders agree that Organiser, and their agents and servants, are not liable for acts of God, the weather, strikes, another pandemic, protests, fires or actions taken by government agencies and similar causes beyond the reasonable control of Festival and understand expenses will not be refunded in whole or in part in these circumstances.

4. Aspects of the Festival including but not limited to programming, ticket price and capacity are subject to change at any time without notice to the holder.

5. The Organiser reserves the right to cancel or postpone the festival for any reason.

6. Any valid refunds will not include the booking fee.

7. Holders should carefully consider the refund and cancellation policies of travel, accommodation and other goods or service providers when making arrangements for attendance at the festival.

8. Holders may also wish to consider taking out a relevant insurance policy to cover for any losses in the event of cancellation, rescheduling or relocation.

9. The Organiser makes no representations in relation to the matters in Items 7 and 8. The Holder is responsible for carrying out all of its own investigations in relation to the Refund and Cancellation Policies for its arrangements associated with the festival and as regards any insurance requirements relevant to the Holder.

In the event the festival date is cancelled as a result of any event beyond the reasonable control of the Organiser, including acts of god, natural disasters, acts of government, strikes, lockouts or other industrial disturbances, blockades, wars, insurrections or riots, epidemics, pandemics, government restrictions, landslides, fires, storms, floods, explosions or other similar causes beyond the control of the Organiser, full or partial refunds of tickets or granting credit vouchers, shall be at the Organiser's sole and absolute discretion and will only be provided in the event such refunds or credit vouchers do not detrimentally impact Festival's legitimate business interests.
